## Origins of Carp in South Western Ontario

Carp are large members of the minnow family (*Cyprinidae*). They originated in Europe and Asia (many varieties) 8 Asian species where they were wild and also domesticated for food and trade spanning over 2,000 years.

As the U.S and Canada was settled and began to develop industries rapid population growth resulted in large harvests and marketing of valued native species. By the mid to late 1800's fish stocks began to decline at an alarming rate. The U.S. reaction in 1871 (Grant Presidency) was to appoint the U.S Fish Commission to oversee the nation's fisheries interest. One of its first tasks was to report on "Fishes worthy of Cultivation." Since trout bass and other fish were obviously declining the USFC promoted a fish with advantages that could rapidly populate ponds reservoirs (rivers fragmented by mill dams and tolerate degraded/polluted warm waters) conditions unfavourable to native species.

European carp had high reproductive capabilities, rapid growth and palatable flesh. Furthermore it was thought to be harmless to other fish being an omnivore rather than another fish eater. It was also proven to be able to populate large and small bodies of water effectively.

Rather than delay by 1877 USFC imported 345 carp of scaled, mirror (fewer very large scales) and leather varieties of carp from Germany. The latter variety was hyped as German leather trout. These were propagated in Maryland and Washington DC and by 1879 over six thousand fingerlings were shipped to 24 states. In short order 1879 to 1896 some 2.4 million carp finger-

lings were sent around the U.S and some even going to Central America and Canada. So this "super fish" seemed to be gaining popularity. And make no mistake about it many anglers took to carp fishing with a passion.

Canadian history in this regard, although perhaps much less trumpeted, also had a rising tide of fish stocking and Conservation interest. Alarmed by the declining Fish and Game in Southern Ontario Canada's first Fisheries Overseer (enforcement officer) John W Kerr (Then Secretary of the Wentworth Game and Fish Protective Association that met at Dundurn Castle in Hamilton) was appointed by the Fed Govt 1857 and began licensing and trying to enforce fisheries laws and assess the situation.

Fish culture in Ontario was initiated by Samuel Wilmot who began rearing and transferring rainbow trout, Chinook salmon along with bass and common carp in the 1860's as Atlantic salmon declined and Lake trout

was extirpated in Lake Ontario herring declined in Lake Erie.

In Dunnville a local Doctor naturalist and hunter G.A. MacCallum requested and received permission to stock over 400 common carp in the Grand River in 1892. So between significant stocking on the American side and some from Southern Ontario the earliest carp stocking into Lake Erie was in the 1890's. They certainly took hold.

Wildlife conservationists in Ontario made a major breakthrough in November 1890 when the Mowat Government appointed a Royal Commission on



Game and Fish headed by that same G.A. MacCallum whose Commission reported back within two years –essentially substantiating what the Fish and game clubs were concerned about. This also led to some difficult relations with the Feds that prompted the British Govt to cede fish and game management to Ontario.

So the common carp, organized Fish and Game clubs like our OFAH affiliates of today, and Dunnville were prominent in pressing for the beginning of our modern Conservation (wise use and protection) movement some 111 years ago.

Whether you like or dislike carp (and there are pros and cons on both sides of the argument) it was perhaps the most deliberate and most hyped fish of that day when degraded and dammed fisheries habitats and unchecked exploitation to meet rising population demand and industrialization triggered a political need for a broad based super fish solution. And it was implemented successfully?

As we look at "Green Energy" initiatives that include more dams on more flowing rivers we may again be trading sturgeon walleye and trout habitat for more carp and vegetative wetland monocultures. The same holds for refurbishing obsolete dams and millponds in our Zone and possibly offshore wind farms.

# LARGE GERMAN CARP.

In a bunch of fish shown yesterday by E. G. Blackford at Fulton Market were the largest German carp yet seen coming from the Potomac. One of them, a leather-back carp, weighed over 15 pounds; the other, of the scale variety, 13 pounds. On the occasion of a freshet which took place at Washington some years ago the waters of the Potomac flooded the Government Fish Pond back of the White House, and these carp, then only a few inches in length and weighing not more than 5 ounces, were carried away into the river, and finding plentiful food there have in a short time greatly increased in bulk. As they are true specimens of the German carp, which is not indigenous to the United States; their origin can be positively fixed. It is already quite well known that, by transplantation, the German carp grow much faster in their new surroundings than in the old. To-day carp raisers in Germany are getting their young fish from the United States. The demand for carp is quite active, the best restaurants in New-York buying them. In a very short time German carp will be plentiful in all parts of the United States, and will be one of the regulation fish in the market. The introduction of these fish is due to the United States Fish Commission.

What a great time of year Fall is. I always looked forward to checking hunters in the field and talking hunting when I was in uniform.

Now I look forward to spending time in my tree stand, or in the marsh, or just talking hunting with others who share a similar life choice.

I recently attended two youth hunts in our zone. The Long Point Waterfowlers Assoc. held their 4<sup>th</sup> annual hunt at Long Point. Twenty young hunters and their mentors spent a morning listening and learning about waterfowl hunting from some pretty experienced folks. Duck ID, using a call, setting decoys, cleaning your harvest, and rules and regulations were the order for the morning.

Following a Bbq lunch the young hunters, with new calls and decoys received as part of their goody bags, were taken out into the marsh with a guide in hopes of harvesting some of the wary waterfowl that stopover in one of North America's busiest flyways.

The weather couldn't have been more "ducky" with wind and rain for the better of the afternoon. Harvest for this years hunt was higher than in past hunts, with some of the youth hunters coming back to the unit office with more than a single bird.

In November, I attended the 3<sup>rd</sup> annual youth pheasant hunt at Gold Creek Farms, west of London. This hunt, supported by the Middlesex Stewardship Committee, saw 12 apprentice hunters and their mentors learn some pointers on firearm and hunter safety before trying their hand at shooting some trap. After a morning prayer led by an Elder from the Chippewa of the Thames, they were off to the field with a guide and a dog handler.

Weather couldn't have been better, and although the pheasants weren't holding for the dogs, every youth was able to bag a nice bird.

After a brief lesson on how to clean your harvest, a few birds made it to the deep fryer for lunch.

These 2 hunts demonstrated what willingness from a few dedicated folks can do for our youth who care enough about what hunting has to offer.

I continue to speak at hunter education classes given by local instructor Bert Cronkwright, and always ask the youth there to thank the mentors who have taken the time to spend with them.

We all have a responsibility to spend a little time with our young people and teach them what hunting has to offer.

It's a great lifestyle choice.

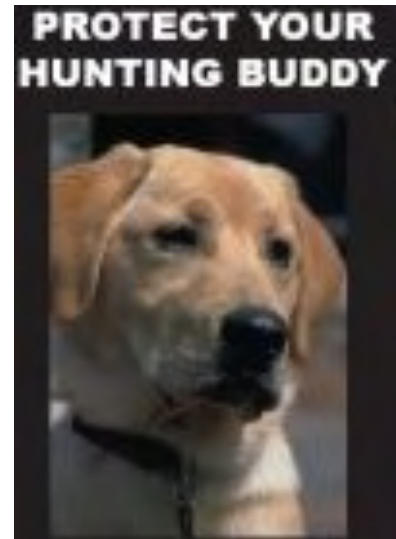

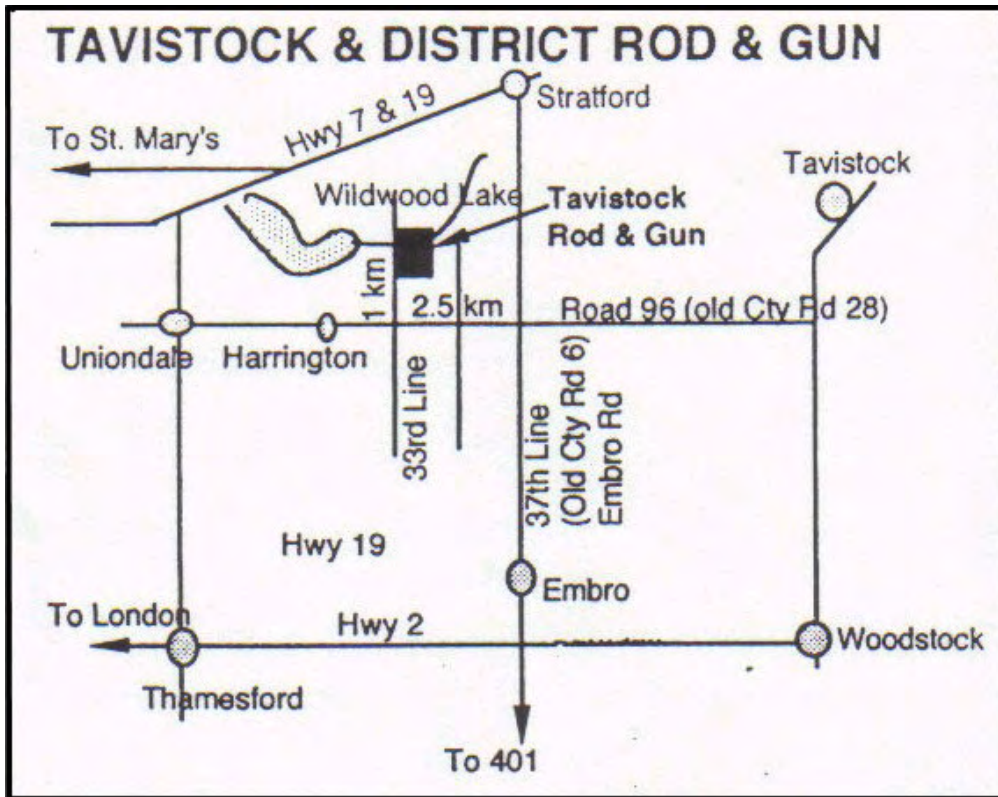
